

On the basis of our review of the annual return, in our opinion the information in the annual return is in accordance with proper practices and no matters have come to our attention giving cause for concern that relevant legislation and regulatory requirements have not been met.

Other matters not affecting our opinion which we draw to the attention of the council:

A. The Chair was acting as the Responsible Financial Officer (RFO) at the time the Council approved the Annual return. The Council has since appointed a new clerk and RFO ensuring that there is now an acceptable level of separation of duties.

B. The Accounts and Audit (England) Regulations 2015 require the RFO to certify, and the Council to approve, the accounts. For 2015/16 the RFO signed the accounts after the Council's approval. We understand that this was a result of the temporary absence of an independent RFO and as a new clerk and RFO is now in place this should not be an issue next year.
