97.0 Parish Council Business

- Update from Meeting with Mr Parsons Cllr Darvas reported that he had met with Mr Parsons.
 Mr Parsons had confirmed that he had met with the landlord of the Bull and Butcher and that the meeting had been productive and that hopefully there woild be no need to take matters any further.
- Update from Mr & Mrs Pridgeon Cllrs Darvas and Jakeman updated the Parish Council of their meeting with the Pridgeons. The clearest message appeared to be that there was concern of being ignored by the Parish Council. The Cllrs reiterated the reasons for the VG Mgt plan and the reasons for doing things in a certain order. It did also show that the Parish Council may also need to communicate its messages in a better way.
- <u>Village Plan</u> Councillor Darvas provided an update on the current status of the proposed Village Plan stating that studying the results of the survey. Cllr Darvas also proposed the introduction of items to be discussed much like the VG Mgt plan. The PC agreed this course of action.
- Village Green Management Plan 3rd discussion Signs Cllr Darvas again updated stating that this item was divided into two sections. The first was around safety signs in the village which may be required by law. Cllr Jakeman wanted confirmation on the cost of the signs. The second is that the Parish Council does not have the power to grant permission to place signs on the Village Green. It was proposed to provide a conditional amnesty for signs currently on the Village Green with the condition that these comply with legal requirements such as Planning Regulations, Conservation Area Regulations, Bucks CC Devolved Powers Agreement, and also to have 3rd Party Liability Insurance.. The details will drafted, confirmed and agreed by the Parish Council.
- <u>Introduction of GDPR</u> Clerk confirmed that PC is currently fully compliant with current regulations
- Willow Trees outside Dr Turner-Smith's residence The tree working Group stated that they
 would be able to pollard the trees. They also asked for permission to purchase and replace the
 dead chestnut tree once it has been removed and invoice the Parish Council for the cost. The
 Parish Council agreed.
- <u>Play Area</u> Cllr Jakeman updated that the checks had been complete and the working party was meeting at the end of February
- <u>Play Area Pressure Washer</u> Cllr Themis confirmed that the new pressure washer had arrived and that once it was up and running he would use it on the play area.

- <u>Conditions of the Village notice Boards</u> Clerk confirmed that Parish Council still waiting fro quotes to come in.
- Speed Watch Cllr Jones confirmed the situation was the same as in January
- Rails outside Ramblers TfB are to replace the rusted railing. Further response is awaited regarding the brick drain Cllr Jones confirmed he is still trying contact Dave Jones.
